Economic Relations Overview - US





USA is India's biggest export destination and 2nd biggest import source.



In 2019, overall US-India bilateral trade in goods and services reached USD 149 billion. U.S. energy exports are an important area of growth in the trade relationship.



3rd Biggest FDI investor in India; 7% share in overall FDI in India during 2000 – 2020.



India-U.S. Dialogue Architecture focuses on Trade & Commerce, Civil Nuclear Cooperation, Defence Cooperation, Counter Terrorism and Internal security.



Bilateral India – US CEO Forum drives the involvement of private sector in trade and investment relations.



India is the No. 1 destination for offshore US software companies.



Major US manufacturing companies are established in Maharashtra including Food Processing, Pharma, among others.

Maharashtra's relations with USA have expanded manifold in the recent years, both in trade, investment and people to people ties.





R&D Initiatives

Under the PACE (Partnership to Advance Clean Energy), the U.S. Department of Energy (DOE) and the Government of India have established the Joint Clean Energy Research and Development Center (JCERDC) designed to promote clean energy innovations by teams of scientists from India and the United States.

USIBC – Maharashtra Agreement

- Maharashtra and the US-India Business Council (USIBC) signed a pact in 2019 to promote the state as an investment destination for American companies.
- The agreement aims to deepen commercial opportunities between American businesses and Maharashtra by encouraging collaboration with American industry. As part of this, the USIBC offices in Washington, San Francisco, New Delhi and Mumbai will function as Maharashtra investment centers.

Intergovernmental Dialogue Mechanisms

- India and the U.S. have more than 50 bilateral inter-governmental dialogue mechanisms for exchange of views on issues of mutual interest.
- Some of the include India US 2+2 Ministerial Dialogue, India US Commercial Dialogue, India US Economic and Financial Partnership, India US Trade Policy Forum, India US Strategic Energy Partnership, India US Homeland Security Dialogue.

Growing Relations

 India became a major defence partner of the US (2016), began the 2+2 dialogue (2018), and signed the Logistics Exchange Memorandum of Agreement (LEMOA, 2016) as well as the Communications Compatibility and Security Agreement (COMCASA, 2018).

• Exxon Mobil signed an MoU with MIDC worth INR 760 Crores in the Oil and Gas Sector.
