- **5.2** If less than two bids are submitted in the stipulated 15 days' time period for any Shed/s, the time period will be extended for 15 days without giving any further advertisement in the newspaper.
- 5.3 If one or more bids are received in this extended period, Technical Envelope-A will be opened. If one or more bidder is/are technically qualified, then Financial Envelope-B will be opened and the application of the Bidder with the highest rate (H-1) will be processed for allotment of Shed. Even in case of single bid technically qualified, financial bid will be opened and given at offered rate.
- **5.4** If two or more technically qualified bids quotes equal/same highest rate in financial Envelope-B, Limited e-bidding for those technically qualified bidders will be conducted and bidder who quotes highest rate in limited e-bidding will be consider for allotment of shed.
- 5.5 Even after extended 15 days period, if one or more bids are not received for any Shed/s, the E-tender(e-bidding) procedure will be treated as cancelled.
- 5.6 The Sheds for which two or more bids are received, but all the bids received are technically disqualified, the E-tender (e-bidding) procedure will be treated as cancelled.
