ECONOMIC OVERVIEW



India-Israel merchandise trade totaled approximately USD 4.45 billion, with India exporting USD 2.13 billion and importing USD 2.32 billion.



India is Israel's 3rd largest trade partner in Asia and 7th largest globally.



Israel's top global and Asian export markets, most recent detailed statistics aren't clearly published. However, India remains a key trade partner in Asia and among Israel's leading export destinations



The arms & ammunition trade has grown explosively: from US \$168,000 in 2015 to US \$185 million in 2024, peaking at US \$265 million in 2023.



In 2024, weapons made up the second-largest import into India from Israel after electrical machinery



Talks are underway to sign a Mutual Investment Protection Agreement, expected to further boost bilateral flows and investor confidence in both directions



In 2023, India was the third-largest investor in Israel by country, with US \$1.2 billion of foreign investment into Israel attributed to Indian investors (notably Adani Group's Haifa Port deal)

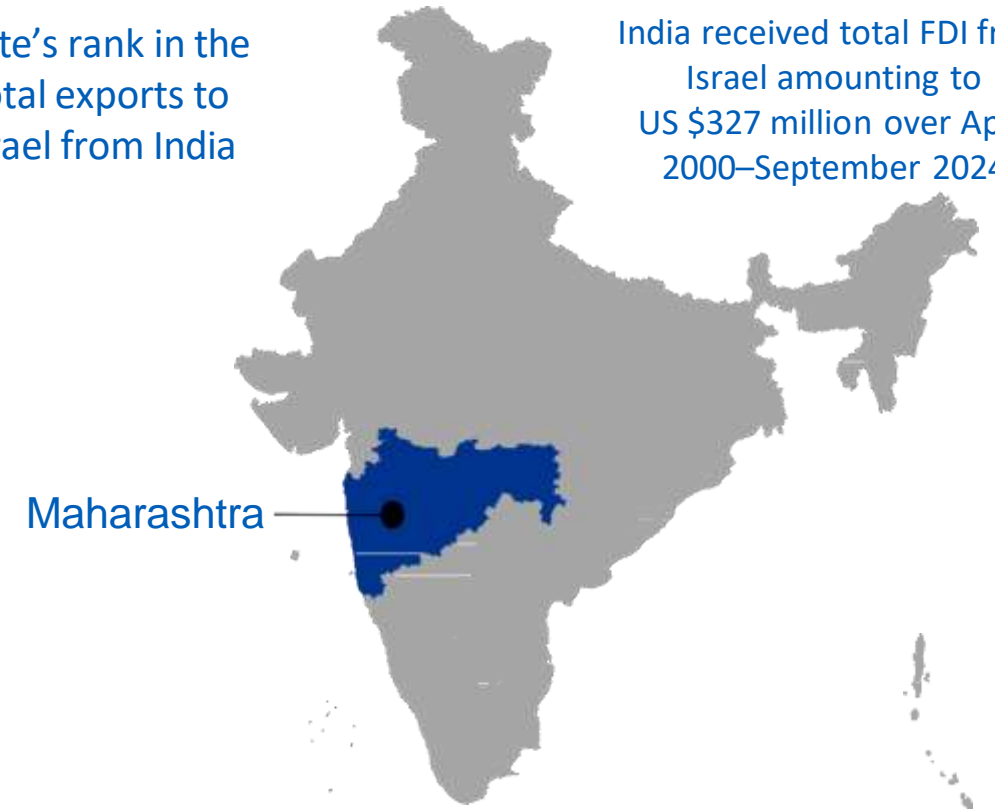
Maharashtra is the biggest and the most attractive investment destination in India with robust policies, mature infrastructure and skilled manpower.

ISRAELI TRADE MISSION

- The Israeli Trade Mission in Mumbai is responsible for western region of India which includes four states that are Maharashtra, Gujarat, Madhya Pradesh and Goa.
- They are responsible for the promotion of Israeli trade and export into the western region of India.

MAHARASHTRA-ISRAEL PARTNERSHIP

- Israeli companies and experts are providing expertise to manage and improve dairy farming in Maharashtra through their expertise in high milk yield.



CULTURAL COOPERATION

- India has signed an MoU with Tel Aviv University for a Chair for Indian studies in the Department of East and Southeast Asian Studies.
- Naan Dan Jain Irrigation Company instituted two annual scholarships for Israeli exponents of Indian art and culture to continue studies in India.
- The Indian Embassy facilitated the Third National Convention of Indian Jews in Israel that was held in August 2015 in Ramle.
